# Goulburn Regional Art Gallery: Gallery 2 Applications 2025-26

#### Background

Goulburn Regional Art Gallery is the sole producer and presenter of contemporary visual arts content in the region. The Gallery is committed to presenting new work from living artists to stimulate and diversify the experiences, knowledge and capacity of the community. The Gallery was inaugurated in 1982 and is located next to the Council Civic Centre, in the central business district of Goulburn.

The Gallery delivers exhibition, education, arts access and outreach programs; manages a growing collection of 500+ objects; and commissions new work for Goulburn Mulwaree Council's public art initiative across the local government area.

#### The Opportunity

Gallery 2 is an important part of our exhibition program and offers an exhibition space to local artists living within a 120km radius of the Gallery and at all stages of their career. This space provides artists with the opportunity to create new work, innovate and develop their practice in a professional context, within a diverse artistic program.

Selected artists will be encouraged and supported to deliver and install a body of work professionally, as well as to provide an informal artist talk during their exhibition.

#### The Artistic Brief

The opportunity is open for application from artists of any age, stage or experience level. The Gallery is excited to receive creative ideas from artists in the region, open to works incorporating any media and of a variety of scales, installed in a variety of ways. The work(s) of art must fit within the designated 'Gallery 2' area, details under 'The Space' below.

The Gallery has previously supported artists in 'Gallery 2' working in the following media: painting, drawing, installation, audio visual works, ceramics, glass, concrete, bronze and many more.

The exhibition statement and application should showcase your practice. You may like to consider the Gallery, the region as well as the intended audience of the general public in your application.

## The Space

The work dimensions must fit in the Gallery 2 exhibition space: Two adjacent walls - 3600mm x 3875mm and 3600mm x 2190mm.

Three-dimensional works must not have a total footprint larger than 2000mm x 1350mm.

We highly recommend a site visit to the Gallery for all applicants in order to visualise the space. You may also like to look at previous installation images in the Gallery 2 space. These can be found on our website under **Exhibitions > View Archive** where there is an entire list of all previous exhibitions. If you click on an exhibition there will be a carousel of install images at the bottom of the exhibition page.

# Artist Requirements

Successful artists must be able to meet the following requirements:

- Artists are responsible for all costs involved in preparing and making the artwork, framing and transport to and from the Gallery.
- The artist will be responsible for installing their work, with some support from Gallery staff. It is essential that the artist provides detailed install requirements for proposed work and demonstrate Public Liability insurance status.
- The artist must be able to deliver an artist talk or public program at the Gallery during the exhibition period.
- Preference will be given to new work.
- Artist has not exhibited in Gallery 2 or a solo exhibition at Goulburn Regional Art Gallery for 12 months.

## Artist fees

Successful artists will each receive a fee of \$750.00 (plus GST if applicable) upon the installation of the exhibition.

Successful artists will also receive the following in-kind support from the Gallery:

- Exhibition development, curatorial and administration support.
- Wall label and other physical supports within reason and availability i.e. wall shelves and plinths.
- Marketing and advertising of exhibition on website, socials and other platforms.

# Further considerations for applicants

- The support material provided must be the artist/s own original work.
- The practice of the artist should be of high quality and strong artistic integrity.
- The support material should be relevant and responsive to this opportunity.
- The selected artist/s will be required to enter into a formal agreement with Goulburn Regional Art Gallery for their exhibition.
- Applications must include all requested items detailed on Page 3.

# Selection criteria

The successful artists will be selected based on:

- The artistic merit and appropriateness of the work samples provided, as relevant this opportunity.
- The quality, originality, and distinctiveness of the artist's practice.
- The clarity, strength and suitability of the proposed exhibition in relation to the opportunity, with consideration given to relevance to the region and/or community.
- Contribution to a diverse calendar of exhibitions in terms of content and approach.
- The capacity to meet requirements and delivery expectations.

## **Selection process**

This is an open request for artists living in a 120km radius of the Gallery. Applications will be assessed according to the selection criteria.
